CLAUDIO KAWA HERMOLIN**, submitted, on this Thursday morning (June 6, 2019), their letters of resignation from the position of sitting members of the Board of Directors of Brasil Brokers. In his letter, Mr. Claudio Kawa Hermolin made a point of reaffirming his commitment to and satisfaction in continuing to work as the Company's CEO, CFO, Controller and IRO.

In view of these resignations, the remaining members of the Board of Directors, Sidney Breyer, Guilherme Aché and Luis Henrique Moura Gonçalves, met and elected **MR. RONALD ADALBERT RAWALD** and **MR. EDUARDO VIDIGAL ANDRADE GONÇALVES** to hold the positions of the sitting members of the Board of Directors of Brasil Brokers until the end of this term of office, which will expire at the Company's next Annual Shareholders' Meeting, which will resolve on the accounts for fiscal year 2019, in compliance with the By-laws.

Mr. Ronald Adalbert Rawald is head of international real estate and senior managing director of Cerberus Capital Management, having occupied several other positions in the same institution over the last 13 years. Previously, he worked at the Fortress Investment Group in Frankfurt; Aetos Capital, where he was one of the founding partners; Morgan Stanley, covering the Asian market; and Merrill Lynch, totaling 30 years of experience in the real estate market. Mr. Ronald Adalbert Rawald earned a degree from Indiana University and an MBA from Fordham University.

Mr. Eduardo Vidigal Andrade Gonçalves is a founding partner and manager of UV Gestora de Recursos, having previously worked as an Officer at Banco Finasa de Investimentos and in the capital market area of Banco Pactual and Banco Credit Commercial de France.

Finally, the Company would like to thank Mr. Eduardo de Castro Magalhães Marques and Mr. Claudio Kawa Hermolin for the services provided while they were sitting members of the Board of Directors, as well as wish good luck to Mr. Ronald Adalbert Rawald and Mr. Eduardo Vidigal Andrade Gonçalves in their new challenges in the Company.
